NANOG 46 Content

- 50 Talks Submitted
- 4 Withdrawn (8%) / 7 Pending (14%)
- 13 Declined (26%)
 - Insufficiently detailed presentation
 - Not topical/not novel
 - Insufficiently technical for audience
- 26 Accepted (52%)

Proposal Content Requirements

Talks

Abstract plus (at least) outline of slides you plan to present.
 To be successful, you should provide as much content as possible.

Panels

- Abstract plus list of panelists

BoFs

 BoFs have less formal requirements. Generally an abstract is sufficient

Lightning Talks

 Like BoFs, lightning talks have less formal requirements and an abstract is sufficient

PC Evaluation Process

- Process starts by PC members rating talks in the "PC evaluation tool"
 - Allows for a rating of "none" or a numeric rating in the range 1-5
 - Allows for comments seen only by the PC and comments for authors
- During PC meetings, members discuss the merits of proposals
 - Talks (with slides, if applicable) with mean rating >= 4.0
 are generally accepted
 - Those will lower ratings are discussed among members
 - Talks can be conditionally accepted if content is deemed interesting but materials need refinement

PC Evaluation Process

Talks with mean rating < 3.0 are generally rejected

A similar process is followed for BoFs, Panels, and Lightening talks

Important Dates

- CFP
 - In general, the CFP is published 3 months prior to the meeting date
- Initial Proposals Due
 - Approximately 2 months before the meeting date
- First Acceptance Notification
 - Could be as early as immediately after the first meeting of the program committee to review submissions
- Draft Agenda Published
 - Like to have this 2 months before the meeting date

Important Dates

- Final Speaker Materials Required
 - 6 weeks before the meeting date
- Final Agenda Published
 - Two months before the meeting date
- First Round of Lightening Talks Open
 - One month before the meeting date

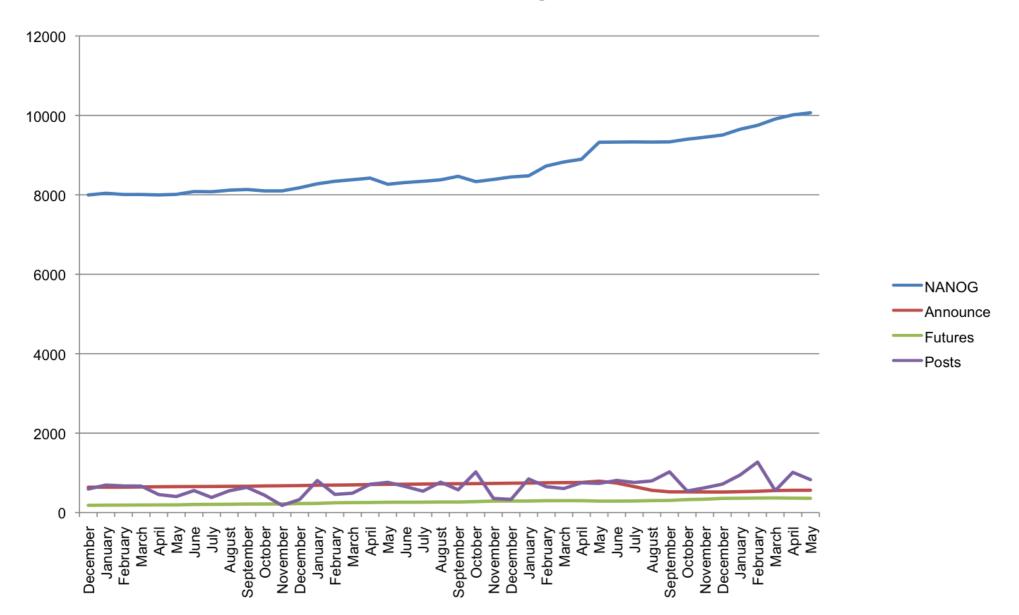

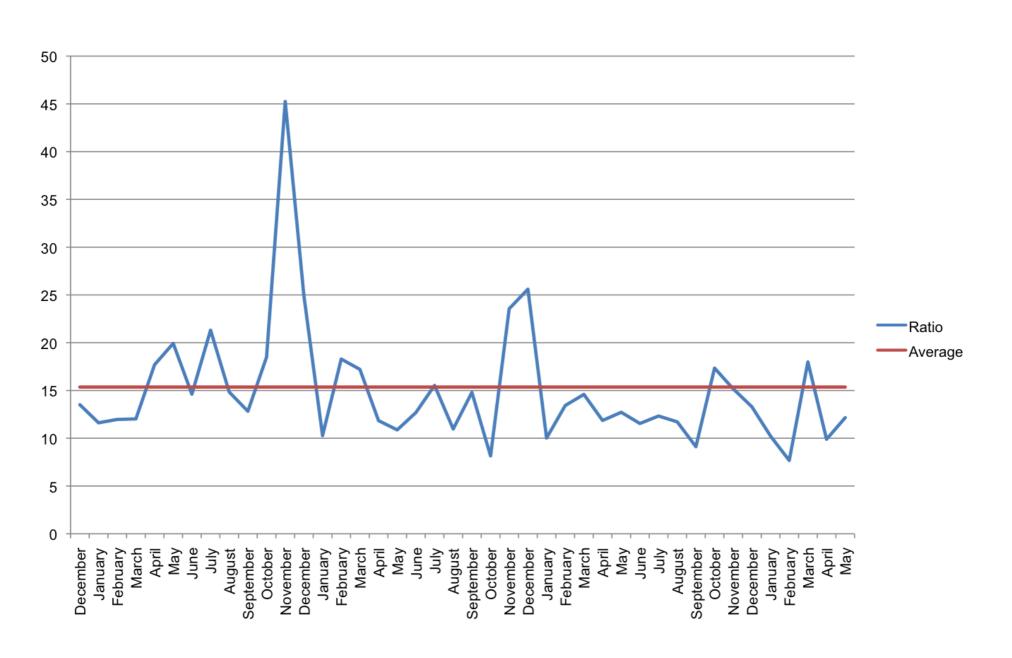

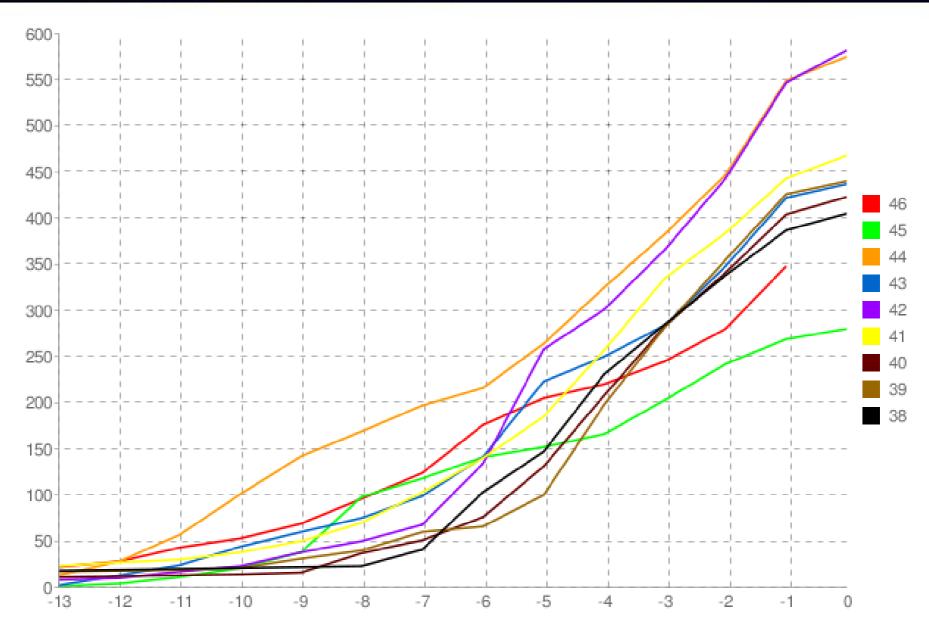

Possible Charter Changes

Charter Amendment Process

- General election during the last meeting of each calendar year
- Amendments added to the ballot by:
 - Steering Committee vote
 - Petition by at least 30 eligible voters, or 1% of eligible voters, whichever is greater

Why?

- The NANOG charter is our equivalent of corporate bylaws or a constitution
- It specifies organization, responsibilities, and authority of the various entities comprising NANOG
- Amendments can fix process errors, reduce ambiguity, and deal with changing circumstances

How to Help

- Submit ideas on nanog-futures
- Volunteer as community coordinator
 - Coordinate with SC
 - Collect and track proposals
 - Lead discussion on nanog-futures
